1 This amendment (“Amendment”) to the Joint Stipulation and Settlement Agreement of Class  
2 Action Claims (“Settlement Agreement”) is entered into by and between Plaintiff Alfonso Diaz on the  
3 one hand, and Defendant Waste Connections US, Inc., on the other hand.

4 This Amendment incorporates by reference all terms and conditions of the Settlement

6 Settlement Agreement terms and conditions will remain effective and enforceable. Any  
7 inconsistencies or differences between this Amendment and the Settlement Agreement will be  
8 interpreted and construed in favor of this Amendment.

9 **AMENDED TERMS AND CONDITIONS**


10 1. Paragraph 2 of the Settlement Agreement is amended to state:

11 ““Administration Costs” means the actual and direct costs reasonably charged by the  
12 Settlement Administrator for its services in administering the Settlement not to exceed \$25,950.00.”


13 2. Paragraph 52(d) of the Settlement Agreement is amended to state:
